Founded in 1984, COA brings together and empowers over 115 organizations, hundreds of businesses and thousands of citizens to protect nature's most important resource: the ocean. The professional staff includes PhD's, an attorney, and several with master's degrees. The dynamic and effective team applies research, education, and citizen action to reduce sources of pollution and impacts from climate change with fact-based campaigns to implement environmentally-sound solutions. COA also engages meaningful and authentic efforts to ensure environmental justice.

ACCOMPLISHMENTS: Significant improvements to marine water quality by reducing sources of pollution, plastics, and climate change, including:

- * ended ocean dumping of eight ocean dumpsites off the coast of NJ

EDUCATION PROGRAMS

COA created the Beach Sweeps - the region's longest running largest bi-annual volunteer citizen science event for all ages that puts feet on the beach and hands in the sand to reduce marine debris and collect a legacy of information that is used to identify sources of marine debris, monitor trends and promote solutions. COA also developed "Watershed Mindfulness" programs to engage people in pollution reduction at the local level, as well as coordinating diverse and engaging educational programs for all ages (youth - seniors), to reduce pollution, climate change and plastics.
